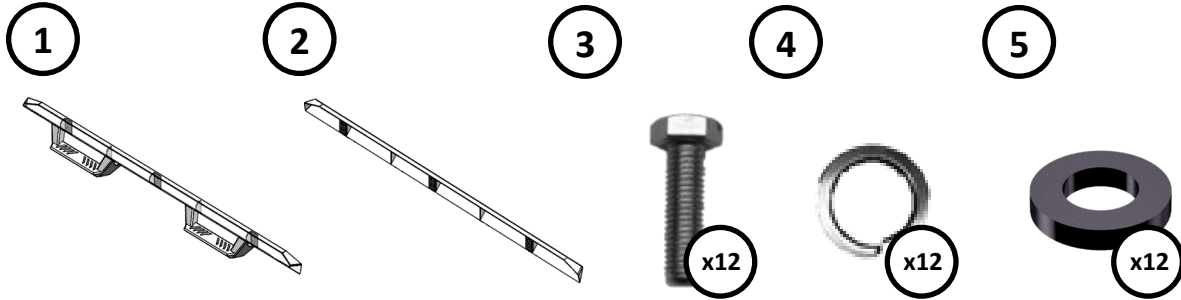

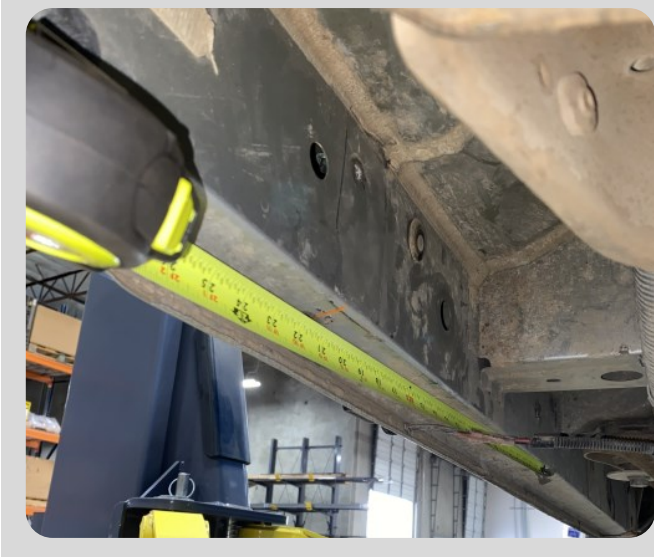
Step 1:

If your Land Cruiser® currently has running boards, remove them prior to proceeding. If equipped, remove the OE running board light and secure the harness out of the way with a zip tie. Be sure to keep the plug away from hot parts and pinch points. Remove steps and hardware from the box. Confirm you have all the components needed for installation. Then, remove the **Driver Side Angular Drop Step** from the packaging and measure the distance between the first set of mounting brackets.

Step 2:

Underneath your Land Cruiser®, clean the mounting surfaces using some rubbing alcohol and a cloth. Find the first set of mounting holes and confirm the distance is the same as measured in Step 1.



Step 3:

With the assistance of a second person, lift the step up into place and align the (3) welded mounting brackets to the OE holes on the frame of your Land Cruiser®. Loosely secure the brackets to the vehicle using (6) M8-1.25x30mm Bolts, (6) M8 Split Lock Washers and (6) M8 Flat Washers. Do not torque the hardware yet.



Step 4:

Confirm you are happy with the fitment and placement of the step. Then torque all hardware to spec using the guide on Page 6.

Installation is now complete.

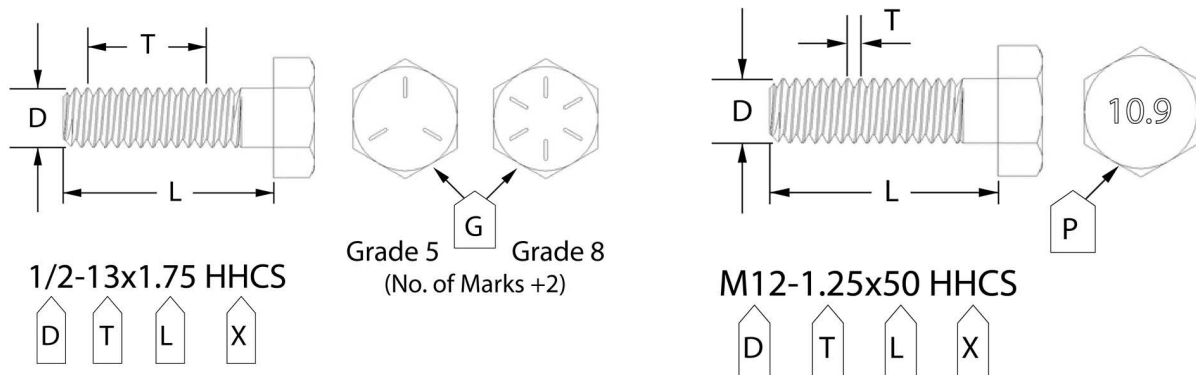

Product cleaning and maintenance instructions

Stainless Steel Finish – Aluminum polish may be used to polish small scratches and scuffs on the finish. Mild soap, window or glass cleaner may be used to clean the finish. Dual state powder coat finish – Mild soap, window or glass cleaner may be used to clean the finish. In order to protect the finish, you may wax your product on a regular basis with pure carnauba automotive wax. Do not use any types of soap, polish or wax that contains abrasive that could damage the finish. Textured coated finishes should be cleaned with a mild soap on a damp sponge. Do not apply polish or wax that requires to be removed by means of buffing. This type of wax is commonly used at car wash facilities. Chrome Finish – Mild soap, window or glass cleaner may be used to clean the finish. In order to protect the finish, you should wax your product on a regular basis with pure carnauba automotive wax. Do not use any types of soap, polish or wax that contains abrasive that could damage the finish.
